## Formulation of the "Net Zero Greenhouse Gas Emissions Declaration"

We are pleased to announce that we have formulated the "Net Zero Greenhouse Gas (GHG) Emissions Declaration."

## Declaration of Net Zero GHG Emissions

We, the Tokai Tokyo Financial Group,\* declare the following as self-imposed goals to realize early a carbon-free society in accordance with the spirit of "Social Value & Justice comes first," the action guideline of our five-year management plan "Beyond Our Limits" launched in April 2022. Also, we will pursue the said goals to attest to our endorsement of the "Paris Agreement" adopted in December 2015 and "Carbon Neutrality by 2050" announced by the Japanese Government in October 2020.

- ✓ Reduce GHG emissions associated with in-house operations (Scope 1 and 2) to net zero by 2030.
- ✓ Regarding GHG emissions associated with in-house operations (Scope 1 and 2), set an interim target of reducing them by half by March 2027 compared to the actual results for fiscal 2021, and disclose the progress as the medium-term management plan KPI.
- ✓ By fulfilling the role as a financial service provider, the Group works together to
